FIREARM & AMMO TRANSFERS TO OUT-OF-STATE RESIDENTS©

States identified in the chart have additional state transfer or possession rules, or limit **LONG GUN** transfers based on firearm or ammunition characteristics. As a result, the State statutes restrict the regular **non-resident LONG GUN** firearm transfer and all ammo sales processes. Federal and state long gun and ammunition sales regulations apply for all drop ships and out-of-state purchases. (*) indicates special dealer permits or training.

STATE RESTRICTIONS

For Restrictive States: Contact JC/JB when completing long gun or ammunition transfers for these states listed on this chart if you still have questions. There are no known restrictions for states excluded from the chart.

REMINDER: “Handguns” and “Other” type firearms are not transferable to out-of-state-residents. In addition, out-of-state Concealed Weapon Permits DO NOT qualify for NICS/POC background check exemptions (ATF Form 4473 box 29).

For non-licensee transfers (residents/non-residents) **under 21 years of age**, the Bipartisan Safer Communities Act allows FBI-NICS or the POC for your state to extend the background checks up to 10 days **ONLY IF NECESSARY** to complete a background check. If the FBI-NICS or POC approves / proceeds your “under 21” transferee, you may transfer that long gun at any time after the approval / proceed is received if your state allows it.

Alabama

- **NICS background check exemption (in-state):** (optional) with concealed handgun permit issued within last 5 years.

Alaska

- **NICS background check exemption (in-state):** (optional) with concealed handgun permit marked “NICS Exempt” issued within last 5 years.

Arizona

- **NICS background check exemption (in-state):** (optional) with concealed handgun permit issued within last 5 years.

Arkansas

- **NICS background check exemption (in-state):** (optional) with concealed handgun permit issued within last 5 years.

California

- **Assault Weapon Ban:** Assault Weapons prohibited.
- **Magazine Capacity:** Limited to 10 rounds.
- **Transfer Delays:** 10-day waiting period for all firearm transfers, up to 30 days for DOJ to approve (in-state).
- **Purchase Requirements:** State-issued safety certificate required; must be 21 to purchase any firearm.
- **Transfer Limits:** No longer a limit on number of guns purchased in any month.
- **Private Party Transfers** must be conducted through an FFL.
- **Firearm Restrictions:** State-approved firearms “roster”; residents cannot purchase firearms or ammo out-of-state; online purchases limited to “CA-Approved” firearms.
- **Ammunition Regulations:** Prior> Must be purchased with a background check through a CA FFL; must be 21 to purchase; ammo shipments must go to an FFL unless recipient has an FFL03 and COE; restricted drop ships of ammo.> **Enforcement and process suspended by 9th Circuit Court on 7/24/25 – permanent injunction against enforcing the law. Ref; Rhode v Bonta et al, 9th U.S. Circuit Court of Appeals, No. 24-542.**
- **Registration:** 60-day registration period for new residents importing “CA-approved” firearms.
- **Black Powder** firearms with a frame/receiver require a DROS purchase, and background check if breech-loading or can accept or be converted to accept conventional ammunition cartridges currently available in the United States. True “antiques” exempt from DROS and Form 4473.
- **State Licensing:** this state has instituted several requirements for FFLs and their employees that must be completed prior to handling, selling or transferring firearms and/or ammunition. This may include a state permit, background checks, special training or certification, etc.

Colorado

- **Assault Weapon Ban:** Limited ban in Denver County, Boulder, and Town of Vail.
- **Magazine Capacity:** Limited to 15 rounds (excluding tubular magazines for .22 cal. and lever-action firearms); shotgun capacity limited to 28 inches of shells or 8 shotgun shells. *10 round capacity in unincorporated Boulder County (only applicable for FFLs and residents selling/buying/possessing) – currently unenforceable due to litigation.
- **Transfer Delays:** 3-day mandatory waiting period effective 10/1/23; waiting period is 72 hours from background check initiation or until approval, whichever is later. Exceptions for family members purchasing from active military being deployed within 30 days.
- **HOLD Exemption:** See above regarding active-duty military family members. **No exemptions** for pawn redemptions or CHL holders or law enforcement or active-duty military for the “72 hour waiting period”.
- **Purchase Requirements:** Must be 21 to purchase firearms (effective 08/07/2023, CO SB23-169); long-gun exceptions for active-duty military or certified peace officers 18-20 years old.
- **Private Party Transfers** must be conducted through an FFL; must receive “approval” or “proceed” for transfers.
- **Taxation:** 6.5% excise tax on retail sales of guns, ammo, and parts effective 4/1/25.
- **SPECIAL:** all firearm transfers require a “Proceed” (Approval).
- **State Licensing:** this state has instituted several requirements for FFLs and their employees that must be completed prior to handling, selling or transferring firearms and/or ammunition. This may include a state permit, background checks, special training or certification, etc.

Connecticut

- **Assault Weapon Ban:** Prohibited or limited; Any semi-automatic centerfire rifle, regardless of the date produced, that has the ability to accept a detachable magazine and has at least one of the following features: 1) A folding or telescoping stock; 2) Any grip of the weapon, including a pistol grip, thumbhole stock, or other stock that would allow an individual to grip the weapon, resulting in any finger on the trigger hand in addition to the trigger finger being directly below any portion of the action of the weapon when firing; 3) A forward pistol grip; 4) A flash suppressor; or 5) A grenade or flare launcher; 6) no assault-style semi-automatic **shotguns** with detachable magazines, adjustable/folding stocks, or pistol grip handles, 7) any semi-automatic firearm other than a pistol, revolver, rifle or shotgun, regardless of the date produced, that has the ability to accept a detachable ammunition magazine that attaches at some location outside of the pistol grip, any semi-automatic firearm with an arm brace attached.
- **Magazine Capacity:** Limited to 10 rounds.
- **Transfer Delays:** Two-week waiting period for long gun transfers out-of-state unless exempt (LE, valid hunting license, or carry permit). Up to 60 days for CSP to approve (in-state).
- **Purchase Requirements:** Permit to purchase (Certificate of Eligibility) required for handguns; ammunition certificate or state-issued gun permit required for ammo purchases; must be 18 for ammo.
- **Private Party Transfers** must be conducted through an FFL.
- **Firearm Restrictions:** Handgun registration required; long guns (non-assault weapons) and ammo purchased out-of-state exempt from eligibility requirements.
- **Ammunition Regulations:** Restricted drop ships of ammunition; special permit or CHL required.
- **Black Powder** firearms are not restricted however, a hunting license, pistol permit or eligibility certificate required for purchase of black powder ammo / supplies.
- **State Licensing:** this state has instituted several requirements for FFLs and their employees that must be completed prior to handling, selling or transferring firearms and/or ammunition. This may include a state permit, background checks, special training or certification, etc.

Delaware

- **Assault Weapon Ban:** Prohibited or limited.
- **Magazine Capacity:** Limited to 17 rounds; CCW permit holders exempt.
- **Handgun Qualified Pistol Permits (HQPP)** ; required as of 11/16/2025.

- **Private Party Transfers** must be conducted through an FFL.
- **Transfer Delays:** up to 25 days for DSP to approve (in-state).
- **HB 451** prohibited individuals between the ages of 18 and 21 from purchasing, owning, possessing, or controlling most firearms. **September 2025**, the Delaware Superior Court in the case *Birney v. RLG Delaware Dept.* held that the part of the state law that imposed a firearm ban on **18- to 20-year-olds** was **unconstitutional** as it violated the right to keep and bear arms under the State Constitution. until the state officially clarifies or appeals the ruling. **As of now, individuals aged 18-20 in Delaware may purchase/possess firearms (handguns or long guns) unless another law prohibits them (felony record, DV misdemeanor, etc.).** The prior state law that barred them was struck down and is not currently enforceable. However — FFLs and dealers should remain cautious: state legislative or appellate action might still change the status, and some regulatory or permit-to-purchase laws are under process.
- **State Licensing:** this state has instituted several requirements for FFLs and their employees that must be completed prior to handling, selling or transferring firearms and/or ammunition. This may include a state permit, background checks, special training or certification, etc.

Florida

- **Transfer Delays:** 3-day hold or time to complete background checks, whichever is later; 5-day hold in Palm Beach, Broward, and Miami-Dade counties; excludes weekends and holidays; waived for Florida Concealed Weapon license holders or those with 16-hour hunter safety course certification.
- **Purchase Requirements:** Must be 21 to purchase any firearm.
- **HOLD Exemption:** No statutory exemptions for pawn redemptions or private transfers by law enforcement.

Georgia

- **NICS background check exemption (in-state):** (optional) with concealed handgun permit issued within last 5 years.

Hawaii

- **Assault Weapon Ban:** Assault pistols (AR & AK) banned.
- **Magazine Capacity:** Limited to 10 rounds for handguns; no limit for long guns.
- **Transfer Delays:** 14-day minimum "hold" after permit application.
- **Purchase Requirements:** Must be 21 to purchase any firearm and apply for a permit to purchase; must be 21 to purchase ammunition.
- **Firearm Restrictions:** Every firearm must be registered with CLEO; firearms brought into the state must be registered within 3 days.
- **Black Powder** rifles and pistols are considered firearms.
- **NICS background check exemption (in-state):** (optional) with concealed handgun permit issued within last 5 years or "Permit to Acquire" permit.
- **State Licensing:** this state has instituted several requirements for FFLs and their employees that must be completed prior to handling, selling or transferring firearms and/or ammunition. This may include a state permit, background checks, special training or certification, etc.

Idaho

- **NICS background check exemption (in-state):** (optional) with concealed handgun permit issued within last 5 years.

Illinois

- **Assault Weapon Ban:** Residents cannot lawfully purchase an AR 15 or assault weapon after January 11, 2023. Certain semiautomatic rifles and handguns restricted.
- **Magazine Capacity:** 10 rounds for long guns and 15 rounds for handguns.
- **Transfer Delays:** 72-hour waiting period for all firearms starting when the buyer agrees to make the purchase.

STATE RESTRICTIONS

- **Purchase Requirements:** State permit (FOID Card) required to purchase; residents can only purchase in-state or contiguous states (IN, WI, IA, MO, KY).
- **Private Party Transfers** must be conducted through an FFL (effective 7/1/23).
- **Firearm Restrictions:** Threaded Barrels on handguns, shrouds, detachable magazine outside the grip restricted.
- **Ammunition Regulations:** FOID card required to purchase or ship ammunition; restricted drop ships of ammunition; special permit/FOID and state ID required.
- **Black Powder** rifles and pistols are considered firearms. FOID card required but no B-G check or Form 4473 required. Does not have to be acquired or disposed through bound book.
- **State Licensing:** this state has instituted several requirements for FFLs and their employees that must be completed prior to handling, selling or transferring firearms and/or ammunition. This may include a state permit, background checks, special training or certification, etc.

Indiana

- **NICS background check exemption (in-state):** (optional) with concealed handgun permit issued within last 5 years.

Iowa

- **NICS background check exemption (in-state):** (optional) with concealed handgun permit issued within last 5 years.

Kansas

- **NICS background check exemption (in-state):** (optional) with concealed handgun permit issued within last 5 years.

Kentucky

- **NICS background check exemption (in-state):** (optional) with concealed handgun permit issued within last 5 years.

Louisiana

- **NICS background check exemption (in-state):** (optional) with concealed handgun permit issued by the state (not Sheriff or County issued) within last 5 years.

Maine

- **Transfer Delays:** 3-day (72-hour) waiting period effective 8/9/24. **Preliminary Injunction applied 2/13/25. Enforcement of the hold is currently suspended.**

Maryland

- **Assault Weapon Ban:** Assault pistols and rifles prohibited or limited.
- **Magazine Capacity:** Limited to 10 rounds for detachable magazines.
- **Transfer Delays:** 7-day waiting period for all handgun transfers.
- **Purchase Requirements:** Handgun Qualification License (HQL) required.
- **Transfer Limits:** One regulated firearm purchase per 30-day period.
- **Private Party Transfers** must be conducted through an FFL.
- **Firearm Restrictions:** Handgun roster; registration of regulated firearms (Form 77R).
- **State Licensing:** this state has instituted several requirements for FFLs and their employees that must be completed prior to handling, selling or transferring firearms and/or ammunition. This may include a state permit, background checks, special training or certification, etc.

Massachusetts

STATE RESTRICTIONS

FIREARM & AMMO TRANSFERS TO OUT-OF-STATE RESIDENTS©

- **Assault Weapon Ban:** Assault Weapons prohibited. Semi-automatic centerfire rifles, semi-automatic pistols and semi-automatic shotguns accepting detachable magazines and/or with two or more specified features (e.g., folding stock, pistol grip, threaded barrel).
- **Magazine Capacity:** Devices capable of holding more than 10 rounds of ammunition or more than 5 shotgun shells.
- **Purchase Requirements:** Firearms ID Card (FID) required; residents cannot purchase out-of-state. Semi-automatic shotguns and rifles now require a License to Carry (LTC) instead of a Firearm Identification (FID) card.
- **Ammunition Regulations:** Firearms ID required for ammunition purchases; restricted drop ships of ammunition; special permit/FID required.
- **Black Powder** firearms with a frame/receiver require FID or LTC to purchase, and background check if breech-loading or can accept or be converted to accept conventional ammunition cartridges currently available in the United States. FID or LTC required for purchase of black powder ammo / supplies. True "antiques" exempt from FID, LTC and Form 4473.
- **NICS background check exemption (in-state):** (optional) with concealed handgun permit issued within last 5 years or License to Purchase.
- **State Licensing:** this state has instituted several requirements for FFLs and their employees that must be completed prior to handling, selling or transferring firearms and/or ammunition. This may include a state permit, background checks, special training or certification, etc.

Michigan

- **Purchase Requirements:** License to Purchase (LTP) required for handgun purchases.
- **NICS Exemption with LTP or CPL as of May 23,2025. (background check is optional).**
- **Private Party Transfers** must be conducted through an FFL.
- **Firearm Restrictions:** All firearm sales require a locking device.
- **Black Powder Guns may not be sold to felons.**

Minnesota

- **Transfer Delays:** 30-day waiting period for private party transfers of semi-auto pistols and assault weapons through CLEO (effective 8/1/23).
- **Purchase Requirements:** Permit to purchase or CCP/CPL required for assault weapon transfers from FFLs.
- **Private Party Transfers** for semi-auto pistols and assault weapons must be conducted through an FFL or CLEO.
- **State Licensing:** this state has instituted several requirements for FFLs and their employees that must be completed prior to handling, selling or transferring firearms and/or ammunition. This may include a state permit, background checks, special training or certification, etc.

Mississippi

- **NICS background check exemption (in-state):** (optional) with concealed handgun permit issued within last 5 years.

Missouri

- **NICS background check exemption (in-state):** (optional) with concealed handgun permit issued within last 5 years. Excludes "provisional" carry permits issued.

Montana

- **NICS background check exemption (in-state):** (optional) with concealed handgun permit issued within last 5 years.

Nebraska

- **NICS background check exemption (in-state):** (optional) with concealed handgun permit issued within last 5 years or Certificate to Purchase.

Nevada

- **NICS background check exemption (in-state):** (optional) with concealed handgun permit issued within last 5 years.

New Jersey

- **Assault Weapon Ban:** Assault Weapons prohibited.
- **Magazine Capacity:** Limited to 10 rounds.
- **Transfer Delays:** 7-day waiting period for handguns.
- **Purchase Requirements:** Permit to purchase required; Firearm Purchaser Identification Card (FPID) required for handgun ammunition purchases.
- **Transfer Limits:** Residents cannot transfer firearms out-of-state. One handgun purchase per 30-day period.
- **Private Party Transfers** must be conducted through an FFL.
- **Firearm Restrictions:** Handgun registration required.
- **Black Powder** rifles and pistols are considered firearms.
- **Ammunition Regulations:** Restricted drop ships of ammunition; special permit/CHL/FID required.
- **State Licensing:** this state has instituted several requirements for FFLs and their employees that must be completed prior to handling, selling or transferring firearms and/or ammunition. This may include a state permit, background checks, special training or certification, etc.

New Mexico

- **“Mandatory HOLD” is enjoined (not enforced currently). Until you see official documentation (state agency notice, court order, or law text amendment) indicating enforcement has resumed, you should assume the 7-day waiting period is not being actively enforced because of the block by the 10th Circuit in August 2025...**
- **Private Party Transfers** must be conducted through an FFL.

Nevada

- **Private Party Transfers** must be conducted through an FFL.

New York

- **Assault Weapon Ban:** Prohibited or limited; stockless pistol grips, shockwave-type firearms, muzzle brakes, thumbhole stocks, long gun pistol grips, foregrips, and threaded barrels banned.
- **Magazine Capacity:** Limited to 10 rounds.
- **Purchase Requirements:** Permit required for handguns and semi-automatic rifles; **must be 21 for all semi-automatic firearms.** **Limits:** One handgun purchase per 30-day period in NYC, Nassau and Suffolk counties.
- **Transfer Delays:** up to 30 days for NYSP to approve (in-state). If a delayed response is received, the dealer may not transfer the firearm unless they receive notification from the state police that the transfer is permitted, or 30 days have passed, and then the NICS check needs to be run again. There is an additional 3-day window after the 30 days to receive a response before the transfer can proceed.
- **Private Party Transfers** must be conducted through an FFL.
- **Firearm Restrictions:** Handgun registration required; stricter laws in NYC, Buffalo, Rochester, Albany.
- **Ammunition Regulations:** Background check required for purchases (effective 10/1/23); no drop ships or out-of-state ammo purchases.
- **Black Powder** rifles and pistols are considered firearms.
- **State Licensing:** this state has instituted several requirements for FFLs and their employees that must be completed prior to handling, selling or transferring firearms and/or ammunition. This may include a state permit, background checks, special training or certification, etc.

North Carolina

- **Handgun Private Party Transfers** must be conducted through an FFL.

- **NICS background check exemption (in-state):** (optional) with concealed handgun permit issued within last 5 years.

North Dakota

- **NICS background check exemption (in-state):** (optional) with concealed handgun permit issued within last 5 years.

Ohio

- **Black Powder** guns are considered "firearms" and regulated through FFL dealers. Enforcement may vary by county.
- **NICS background check exemption (in-state):** (optional) with concealed handgun permit issued within last 5 years.

Oklahoma

- **NICS background check exemption (in-state):** (optional) with concealed handgun permit issued within last 5 years.

Oregon

- **Magazine Capacity:** Limited to 10 rounds. (Measure 114 – **pending, not enforced**)
- **Purchase Requirements:** Permit to Purchase required for all firearms (**pending litigation, not enforced**), residents can only purchase in-state and contiguous states only (WA, NV, ID, CA).
- **Private Party Transfers** must be conducted through an FFL.
- **Buyer:** must complete state transfer form and provide thumb print to Oregon FFL. (**ORS 166.412**).
- **Firearm Restrictions:** State transfer and import restrictions.
- **State Licensing (pending, not enforced):** House Bill 3076 - this state has proposed several requirements for FFLs and their employees that will be required prior to handling, selling or transferring firearms and/or ammunition. This may include a state permit, background checks, special training or certification, etc.

Pennsylvania

- **Handgun Private Party Transfers** must be conducted through an FFL.

Puerto Rico

- **NICS background check exemption (in-state):** (optional) with concealed handgun permit issued within last 5 years.
- **State Licensing:** this state has instituted several requirements for FFLs and their employees that must be completed prior to handling, selling or transferring firearms and/or ammunition. This may include a state permit, background checks, special training or certification, etc.

Rhode Island

- **Transfer Delays:** 7-day waiting period for all firearms.
- **Purchase Requirements:** Handgun safety certificate or hunter education course card required for ammunition purchases (effective 12/31/22).
- **Private Party Transfers** must be conducted through an FFL.
- **Ammunition Regulations:** Restricted drop ships of ammunition; special permit/CHL required.
- **State Licensing:** this state has instituted several requirements for FFLs and their employees that must be completed prior to handling, selling or transferring firearms and/or ammunition. This may include a state permit, background checks, special training or certification, etc.

South Carolina

- **NICS background check exemption (in-state):** (optional) with concealed handgun permit issued within last 5 years.

South Dakota

- **NICS background check exemption (in-state):** (optional) with concealed handgun permit issued within last 5 years.

Texas

- **NICS background check exemption (in-state):** (optional) with concealed handgun permit issued within last 5 years.

Utah

- **NICS background check exemption (in-state):** (optional) with concealed handgun permit issued within last 5 years.

Virginia

- **Purchase Requirements:** Non-residents & "dual residents" must provide one photo ID from their home state and one additional ID acceptable by VA Dept. of Criminal Justice Services for their VA residence.
- **Private Party Transfers** must be conducted through an FFL.
- **Transfer Limits:** one handgun purchase per 30-day period without a CHL.
- **SPECIAL:** all firearm transfers require a "Proceed" (Approval).
- **State Licensing:** this state has instituted several requirements for FFLs and their employees that must be completed prior to handling, selling or transferring firearms and/or ammunition. This may include a state permit, background checks, special training or certification, etc.

Vermont

- **Assault Weapon Ban:** Bump stocks restricted.
- **Magazine Capacity:** Limited to 10 rounds for long guns, 15 rounds for handguns.
- **Transfer Delays:** H.230 - 72-hour hold after NICS approval received **or 7 business days** after dealer contacts NICS (delayed), **whichever occurs first**.
- **Purchase Requirements:** Must be 21 to purchase all firearms.
- **Private Party Transfers** must be conducted through an FFL.

Washington, DC

- **Assault Weapon Ban:** Assault Weapons prohibited with limitations; .50 BMG rifles prohibited.
- **Magazine Capacity:** Limited to 10 rounds.
- **Transfer Delays:** 10-day waiting period for all firearms.
- **Purchase Requirements:** Pre-registration (permit to purchase) required for all firearms; must be 21.
- **Transfer Limits:** No out-of-state transfers.
- **Private Party Transfers** must be conducted through an FFL.
- **Firearm Restrictions:** Only licensed dealers, registered firearm holders, or specific officials can possess ammunition.
- **Ammunition Regulations:** No drop ships or out-of-state ammo purchases.
- **Black Powder Guns** regulated as "firearms" under state law and require a background check and 4473.
- **State Licensing:** this state has instituted several requirements for FFLs and their employees that must be completed prior to handling, selling or transferring firearms and/or ammunition. This may include a state permit, background checks, special training or certification, etc.

Washington (State)

- **Assault Weapon Ban:** Semi-automatic handguns and long guns (assault weapons) prohibited or limited (HB 1240). The ban focuses on specific semi-automatic rifles with features like detachable magazines, threaded barrels, and other characteristics associated with military-style weapons.



STATE RESTRICTIONS

FIREARM & AMMO TRANSFERS TO OUT-OF-STATE RESIDENTS©

- **Magazine Capacity:** Limited to 10 rounds.
- **Transfer Delays:** 10-day waiting period for all firearms; defined as 10 business days from background check request.
- **Purchase Requirements:** Must be 21 to purchase semi-auto rifles; safety course certification required for all buyers; State Patrol SAFE program approval required.
- **Private Party Transfers** must be conducted through an FFL.
- **Firearm Restrictions:** Handgun registration required; residents can purchase long guns out-of-state if state requirements met.
- **State Licensing:** this state has instituted several requirements for FFLs and their employees that must be completed prior to handling, selling or transferring firearms and/or ammunition. This may include a state permit, background checks, special training or certification, etc.

West Virginia

- **NICS background check exemption (in-state):** (optional) with concealed handgun permit issued within last 5 years. Excludes "Provisional" carry permits.

Wyoming

- **NICS background check exemption (in-state):** (optional) with concealed handgun permit issued within last 5 years.
